**HYBRID SPECIAL MEETING  
MONDAY, JUNE 20, 2022**

**MEETING LOCATION – CITY HALL 320 SOUTH MAIN STREET AND VIRTUAL THROUGH ZOOM  
CALL TO ORDER – 5:05 P.M.**

**MEETING CALLED TO ORDER BY MAYOR SWEHLA.**

**MEMBERS PRESENT:** Benish, Frame, McClung, Smith-Dischner, Swehla. Baucke and Shay absent.

**ACTION ITEMS**

- A. **ENCROACHMENT PERMIT FOR MEXSU LLC – KARMA WELLS.** Clerk/Treasurer Wells stated that Mexsu LLC is seeking an encroachment permit that would allow them to have dining space on the City sidewalk in front of their business. Smith-Dischner moved to approve the encroachment permit for Mexsu LLC. Second by Frame. Question. 5 ayes. Motion carried.
- B. **PUBLIC HEARING ON LIQUOR LICENSE FOR MEXSU LLC – LOCAL LICENSING AUTHORITY, KARMA WELLS.** Clerk/Treasurer Wells stated that she has received all necessary paperwork from Mexsu LLC, located at 118 S. Main Street, to obtain a liquor license. Public hearing was opened. Hearing no discussion, public hearing was closed. Benish moved to approve the liquor license for Mexsu LLC. Second by Smith-Dischner. Question. 5 ayes. Motion carried.
- C. **CONTRIBUTION TO S.A.R.A. HOUSE – SCOTT MOORE.** Manager Moore presented Council with a request to sponsor a team for the S.A.R.A. House annual golf tournament fundraiser. We have sponsored a team the past 2 years at the \$500 contribution level. Because Council is in the middle of creating a procedure for donation requests, Smith-Dischner stated that she would like to see that procedure process completed before approving the contribution. The item was tabled until the donation procedure process has been completed.
- D. **APPROVAL OF BILLS – KARMA WELLS.** Clerk/Treasurer Wells provided Council with a list of bills. Some discussion was held regarding the next fuel purchase for the tanks at the airport. Smith-Dischner moved to approve the bills. Second by Benish. Question. 5 ayes. Motion carried.
