<p><b>NOTES TO APPLICANT:</b></p> <p>PERMIT AUTHORITY 1204.3 Any Building permit issued shall become invalid unless the work authorized by it shall have been commenced within six (6) months of its date of issue or the work authorized by it is suspended or abandoned for a period of one (1) year.</p> <p>PERMIT VIOLATION 1205. As provided in Chapter 139, Article 86, Section 3 of the Colorado Revised Statutes 1963, as amended, any person, firm or corporation violating any provision of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be fined not less than one dollar (\$1.00) but no more than three hundred dollars (\$300.00).
