# Meeting called to order by Mayor McClung.

## PUBLIC HEARINGS AND OTHER NEW BUSINESS (Action Items)

# A. Approval of SIPA GovGrant Award and purchase of equipment

Interim Manager Wells stated this would approve the SIPA GovGrant for purchase of equipment and installation for the Council meetings to improve the zoom meetings and have language translation. The grant is up to \$40,000. The quote received from Teryx is \$34,122.50. This is a zero match grant. Shay moved to approve the SIPA GovGrant and expenditure of funds towards the grant. Second by Frame. Question. 5 ayes. Motion carried.

Council resumed regular session at 6:35 P.M. A statement was made for who was present in executive session and there were no objections to the discussions in executive session.

#### Announcement of City Manager Finalist and Authorize Negotiations

Mayor McClung stated the City Manager process started with 17 candidates. This was narrowed down to 7 candidates by committee. Those 7 people were then interviewed by zoom KRW. From these interviews, the finalists were narrowed to 4 candidates. These 4 finalists were invited to Yuma for tours. Interviews were conducted Friday with Council and an administrative panel. Council's consensus is to negotiate a contract with Eric Duthie.
