CALL TO ORDER - 6:30 P.M.

APPROVAL OF DECEMBER 5, 2023 AGENDA

Mayor Pro Tem Shay moved to approve the December 5, 2023, Agenda. Second by Benish. Question. 5 ayes. Motion carried.

APPROVAL OF NOVEMBER 21, 2023 MINUTES

Council Member Baucke moved to approve the November 21, 2023 Minutes. Second by Shay. Question. 5 ayes. Motion carried.

ACTION ITEMS

- A. CHANGE DATE OF FIRST JANUARY COUNCIL MEETING KARMA WELLS. City Clerk/Treasurer Karma Wells stated it was discussed at the last meeting to change the first January Council Meeting because of the Mill Levy date changes. The county contacted the City Monday notifying us that the Mill Levy needs to be sent in by the 18th of December. The first meeting in January will no longer need to be changed. A special meeting is set up for December 12th to approve the Mill Levy and budget.
- B. PUBLIC HEARING ON SECOND READING ORDINANCE #9, SERIES OF 2023 (AMEND 2023 BUDGET) KARMA WELLS. City Clerk/Treasurer Karma Wells stated amending the 2023 budget only amends the general fund to increase the expenditures by \$372,097.00. Public Hearing open. No comments were made. Public Hearing closed. Mayor Pro Tem Shay moved to approve the second reading of Ordinance #9, Series of 2023. Second by Smith-Dischner. Question. 5 ayes. Motion carried.
- C. RESOLUTION #23, SERIES OF 2023 (AMENDING THE CITY'S 125 FLEXIBLE BENEFITS PLAN) KARMA WELLS. City Clerk/Treasurer Karma Wells stated this amends the 125 Flexible Benefit Plan. Each year the IRS changes how much can be put into the Flexible Benefit Plan. For 2024 the amount is \$3,200.00. The employees can choose to have this amount or a lesser amount taken out of their check each month. Mayor Pro Tem Shay moved to approve Resolution # 23, Series of 2023. Second by Benish. Question. 5 ayes. Motion carried.

- D. RESOLUTION #24, SERIES OF 2023 (AMENDING THE CITY'S 125 FLEXIBLE BENEFITS PLAN) KARMA WELLS. City Clerk/Treasurer Karma Wells stated this is a change to the Flexible Benefit Plan. This changes in the amount for how much can carry over to the next year. In 2024, the amount changes to a carry over up to \$640. Mayor Pro Tem Shay moved to approve Resolution #24, Series of 2023. Second by Baucke. Question. 5 ayes. Motion carried.
- E. CONSIDERATION OF YEAR END BONUSES SCOTT MOORE. City Manager Scott Moore presented to Council potential amounts for Year End bonuses for City Employees. Council has historically been given 5 choices. Council was provided choices of no bonus, \$250, \$500, \$750 and \$1,000 bonuses Mayor Pro Tem Shay stated \$500 like previous years worked really well with half being in Greenbacks. Discussion was held. Mayor Pro Tem Shay moved to approve year end bonuses in the amount of \$500 with half being chamber bucks for full time employees and cash for part time employees prorated. Second by Baucke. Question. 5 ayes. Motion carried.
- **F.** APPROVAL OF BILLS KARMA WELLS. City Clerk/Treasurer Karma Wells stated an additional 2 lists of bills were handed out. There are none to disclose. Mayor Pro Tem Shay moved to approve the bills. Second by Smith-Dischner. 5 ayes. Motion carried.
- **G. PURCHASES IN EXCESS OF \$5,000 SCOTT MOORE.** Manager Moore asked for ratification of the purchase of fuel for the Airport. The amount is \$14,884.53 for 2,942 gallons of 100 LL fuel. Mayor Pro Tem Shay moved approve the purchase of fuel for the Airport in the amount of \$14,884.53. Second by Smith Dischner. 5 ayes. Motion carried.
