The fee shall be as detailed above, unless actual costs exceed that amount, in which case actual costs may be charged. Actual costs may include staff time. Any fees charged in this policy shall include the cost of redacting documents to excise privileged and/or confidential material. Fees may be waived or reduced with prior approval of the Chief of Police.
